Community • Rewards • Growth

1) Abstract

RAB Coin is a BEP-20 token designed to reward community participation and fund real-world utility. The protocol emphasizes transparent distribution, fair rewards, and sustainable growth via partnerships, staking utilities, and governance.

2) Vision & Mission

Vision: Build a trusted, Kerala-rooted crypto ecosystem that unlocks community value and local innovation.

Mission: Empower the community with fair rewards, transparent allocation, and open governance.

3) Problem & Solution

Problems: Opaque allocations, low local utility, weak long-term incentives.

Solution: Clear tokenomics, real utilities (staking, perks), and community governance.

4) Technology Overview

Standard: BEP-20 on BNB Smart Chain

Security Plan: Third-party audit (planned), timelocks & multisig (planned), bug-bounty (planned).

5) Token Details

Max Supply: 1,000,000,000 RAB

40% — Community Rewards

20% — Development & Marketing

15% — Team & Advisors (12-mo cliff, 36-mo vest)

10% — Liquidity Pool

10% — Strategic Partnerships (24-mo vest)

5% — Reserve (24-mo vest)

6) Utility

- Staking & quest rewards
- Access to gated channels, events, early drops
- Merchant/partner discounts
- Governance voting on grants, treasury, roadmap

7) Economics & Sustainability

No hidden mints; fixed max supply. Rewards are programmatic and decline over time to favor early contributors while ensuring longevity. Treasury spend is publicly reported.

8) Roadmap

1. **Foundation:** Token live, site, socials, initial LP, trackers
2. **Adoption:** Staking/quests, merchant pilots, Grants #1
3. **Scale:** Partner network, wallet integrations, Governance v1
4. **Ecosystem:** New utilities, cross-chain (after security review)

9) Governance

1 RAB = 1 vote (future proposals can improve with delegated/quadratic voting). Scope includes treasury spend, partnerships, reward schedules, and roadmap items.

10) Risks

Crypto assets are volatile. Smart-contract risk, regulation, and liquidity may impact outcomes. Do your own research.

11) Legal
